



CHCA Facility Announcement – FAQs

What's the big news?

Kings Hammer has formed an exclusive, multi-year partnership with Cincinnati Hills Christian Academy (CHCA), securing long-term access to their premier athletic facilities.

Why is this partnership important?

This move gives Kings Hammer a centralized, high-performance training hub in Greater Cincinnati. It enhances field access, balances regional coverage, and reflects our long-term growth strategy.

Where is the new location?

The CHCA athletic campus is located at and around 11300–11312 Snider Rd in Cincinnati. It includes the Christopher D. Lindner Family Stadium Complex, Robert Gardner Baseball Stadium, Lady Eagles Softball Field, and the Robert D. and Richard E. Lindner Athletic Field — all within a quarter mile of one another.

What makes CHCA's facility stand out?

The CHCA athletic campus offers stadium turf, lighting, and elite amenities. It's a best-in-class complex that supports high-level development for youth athletes.

How will CHCA be used?

The CHCA athletic campus will serve as a geographically assigned training option for teams with rosters concentrated near the campus. Beginning Fall 2025, teams will be assigned to CHCA only if it offers a geographic advantage. This is not a blanket reassignment— it's about matching each team to the most convenient and competitive environment.

When will training at CHCA begin?

Teams will begin training at CHCA starting in Fall 2025. Specific assignments and schedules will be shared with families as the season approaches.

Why are we making this move?

To secure long-term access to top-tier facilities, improve regional balance, and increase value and opportunity for all Kings Hammer families.



How will training locations be decided?

Training locations will be assigned based on each team’s geographic makeup. CHCA is being added to better serve centrally located teams — especially those with rosters near the CHCA area. Teams with players primarily from Northern Kentucky or the Warren County region will continue training at their current locations.

Is my team moving to CHCA?

Only if it makes sense geographically. If your team is mostly made up of players who live near CHCA, training may shift there. Otherwise, teams will continue to train at the most convenient location based on their roster — such as Town & Country or Warren County Sports Park.

What about teams in Northern Kentucky?

Teams with primarily Northern Kentucky-based players will remain in Northern Kentucky. CHCA is not replacing current training sites — it complements them to better serve centrally located teams within Greater Cincinnati.

Will teams currently training at Warren County still stay there?

Yes. Teams with rosters concentrated in the northern part of Greater Cincinnati will continue training at Warren County Sports Park. CHCA is being added to serve teams in the middle of our footprint — not to replace or relocate existing programs that are well-placed.

Will team schedules or days change?

No significant changes are expected. Team schedules will be communicated closer to the season, and families will be notified if adjustments are needed.
